From the Bylaws:

**ARTICLE II: BOARD OF DIRECTORS**

Section 3:     Elections: The Board of Directors shall be elected by and from among the Foundation members at the first annual meeting of the directors each year. Directors shall serve two (2) year terms and may serve any number of terms successive or otherwise.

During the initial elections, five (5) of the directors will be elected for a three (3) year term. Four (4) of the directors will be elected for a two (2) year term. Subsequent elections will be two (2) year terms for all directors.

**ARTICLE III: OFFICERS**

Section 2:     Elections: The Officers shall be elected by and from among the members of Board of Directors at the first annual meeting of the directors each year. Officers shall serve two (2) year terms and may serve any number of terms successive or otherwise.

During the initial elections, five (5) of the directors will be elected for a three (3) year term and will include the elected officer positions of President and Treasurer. Four (4) of the directors will be elected for a two (2) year term including the elected officer positions of Vice-President and Secretary. Subsequent elections will be two (2) year terms for all directors.
